Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. The data quality of the raw materials in A1 is presented in the table below.



System boundary:

The product is manufactured and assembled at our production site in Kinnarp, from where it is also shipped to the customer.

For the variants and options connected to this EPD, some metal components are manufactured at our production site in Jönköping. Some plastic components are manufactured at our production site in Skillingaryd, where the fabric for the sound absorbent also is being processed. The remainder of the metal and plastic components are purchased as pre-manufactured components.

The flow chart below illustrates the system boundaries of the analysis.

LCA: Scenarios and additional technical information

The following information describe the scenarios in the different modules of the EPD.

The product is shipped to the consumer in Kinnarps' trucks with blankets and cardboard sheets as packaging material which is returned to the factory after delivery and reused. This method saves 270 kg of packaging material per container and enables 50% more products to be transported in each truck. Kinnarps' trucks have a load efficiency of approximately 87 % and are run on diesel with renewable content. The maintenance scenario includes wet-wiping once a week for the whole reference service life.
